Thank you for respecting our work and livelihood by choosing not to reproduce our images.

Exclusive Photographer: Please only bring the people that will be photographed to the session, or limit additional guests to immediate family (i.e. parents) or one friend (seniors) only; we've found that especially with young children, they tend to be over-stimulated and distracted with an audience, and it becomes much more difficult to capture their true selves. Also, please do not bring your own camera, camcorder, cell phone camera, or any other recording device to the session.

Print Orders: Print orders must be placed within one week of previews being available in order to receive early pricing; for all other orders, please refer to our standard pricing. Due to time and space constraints, any online proof gallery will expire in two weeks; it is highly recommended that you make your purchasing decisions within this time frame. If you would like to re-publish your gallery, there will be a \$25 fee.

Final Prints: Your final print order will be delivered approximately 2-3 weeks after you order. Specialized products such as canvases, painted portraits, sports trading cards, etc. may take up to 4-6 weeks. We will contact you by phone or e-mail to set up a convenient time for your images to be picked up, once they are complete.

Retouching: All proof images will have minimal retouching performed before any images are viewed; ordered images will be more detailed more closely (scars, blemishes, eye circles, stray hairs, etc). If there is anything in particular that you do or do not want touched up, please let us know ahead of time. Any retouching beyond this will be charged a fee of \$35 per hour; this includes braces, removal of logos/words on shirts, etc.

Re-Shoots and Cancellations: Re-shoots are at the discretion of the photographer, and are not provided for regretful personal choices such as hair and clothing choices. If you or your child is feeling ill, please call to reschedule. We are parents too, and we fully understand that sometimes, this just happens. If you must cancel or reschedule for other reasons, please try to do so at least 48 hours before your session.

Travel Fee: There is a \$25 travel fee for locations 25 miles outside of our studio.

Payment Options: Studio H currently accepts cash and checks; VISA and MasterCard are also accepted. Checks returned by the bank, for any reason, will be charged a \$25.00 service charge. A minimum of 50% of the balance is required when prints are ordered. The balance due is payable when prints are received. Portraits not picked up within 6 months will be considered abandoned and may be disposed of. NO REFUND WILL BE GIVEN FOR ANY MONIES PAID ON ABANDONED PORTRAITS.

Reprints: All ordered images will be kept on file for at least one year after your initial order. You are welcome to place a re-print order from the images you originally purchased. There is a \$50 minimum on re-prints.

Sales are Final: Due to the custom nature of each session, all sales are final - proof books that are purchased are not returnable. If there is a problem with one of your images, please let us know, and we will do everything we can to rectify the situation.

Usage: Studio H reserves the right to use images for display, publication, or other purposes. All digital originals and modified files remain copyrighted to and the property of Studio H Photography.
